15. RATEPAYERS REQUEST – MILLER ROAD

Resolution no 38-03/2022

WHEREAS Miller Road is privately owned;

WHEREAS a request was received asking the Municipality of Thorne to take over Miller Road;

WHEREAS the road would need a lot of work to be brought to municipal standards;

FOR THESE REASONS:

It is moved by D. STAFFORD seconded by J. COURSOL and unanimously resolved;

THAT the municipality will not take over this road as it would cost too much money to bring it up to par

and would encounter more expenses for maintenance.

16. <u>INTERNATIONAL DAY AGAINST HOMOPHOBIA AND TRANSPHOBIA</u>

Resolution no 39-03/2022

WHEREAS the Quebec Charter of Human Rights and Freedoms recognizes that no discrimination may be

exercised on the basis of sexual orientation, gender identity or gender expression;

WHEREAS Quebec is a society open to all, including lesbian, gay, bisexual and trans (LGBTQ+) people and

all other people who identify with sexual diversity and the plurality of gender identities and

expressions;

WHEREAS despite recent efforts for greater inclusion of LGBT people, homophobia and transphobia remain

present in society;

WHEREAS May 17 is the International Day Against Homophobia and Transphobia, which is celebrated in

many countries and is the result of a Quebec initiative led by Fondation Émergence since 2003;

WHEREAS there is a need to support the efforts of Fondation Émergence in holding this day;

FOR THESE REASONS;

It is moved by J. COURSOL seconded by D. STAFFORD and unanimously resolved;

THAT May 17 is proclaimed INTERNATIONAL DAY AGAINST HOMOPHOBIA AND

TRANSPHOBIA and that the day is marked as such.

THAT the municipality will also be hoisting the flag.

18. <u>BANNING SYMBOLS OF HATE ACT</u>

Resolution no 41-03/2022

WHEREAS NDP House Leader Peter Julian, MP (New Westminster–Burnaby) tabled Bill C-229, a private

member's bill that would prevent anyone from selling and displaying symbols that promote

hatred;

WHEREAS The symbols that would be banned are Nazi Swastikas and other Nazi emblems of the genocidal

regime, Klu Klux Klan symbols and the Confederate flag, symbols of slavery, racism and of

white supremacy;

WHEREAS Bill C-229 is a tool designed to address the growing violence and hatred in Canadian

communities;

WHEREAS Everyone has the right to feel welcomed, secure and respected in their community; WHEREAS Allowing these symbols of hatred to be freely sold in stores and publicly displayed is

traumatizing for people who have been, and continue to be, targets of violence and oppression;

FOR THESE REASONS,

It is moved by R. BLASKIE and seconded by M. BEAN and unanimously resolved;

THAT the Municipality of Thorne endorses MP Peter Julian's Private Member's Bill C-229

- Banning Symbols of Hate Act.
